PAUL SADLON MOTORS 2024 GREAT ZUCCHINI CONTEST Rules & Regulations



Contest Date: May 11^{th,} 2024 – September 14th, 2024

- To enter, participant must fill out a registration form of all personal information in full. Identification must be provided showing the participant as a resident in Ontario. Without registering, during the registration period, (May 11-June 15) at Paul Sadlon Motors, 550 Bayfield st, Barrie, the non registered Zucchini will not be eligible to enter or win.
- 2. Participants will NOT be able to register on measuring day... Drop-Dead deadline date for Registration is JUNE 15, 2024.
- Participants will be given a package of Sicilian Snake long Zucchini seeds after registering and will be required to use the seeds to grow their Zucchini by September 14th, 2024.
- 4. All participants will be required to bring the Zucchini plant that was grown from the seeds provided by Paul Sadlon Motors on September 14th during the Measuring event day, prior to 3pm.
- 5. There will be 3 categories in this year's adult division contest. Category 1: the Longest Zucchini, Category 2: the Smallest Zucchini, Category 3: Judges' Choice. A winner from each category will be determined on measuring day. A draw amongst the winners of the 3 categories will be done following all measurements of all registered Zucchinis presented on measuring day. The Longest Zucchini will be the Zucchini measuring longest in length. The Smallest Zucchini will be the Zucchini measuring the shortest in length, and the Judges Choice Zucchini will be the one the Judges deem to be their choice Zucchini presented that day. There will be 3 prizes drawn for the 3 finalists: Third Prize: Dinner for 2 at an Italian restaurant from CHIN Radio TV International; Second Prize: \$1,500.00 from Paul Sadlon Motors; Grand Prize: An all inclusive Trip for 2 to the 2025 CHIN Winter Picnic courtesy of CHIN Radio TV International.
- 6. The New Junior Division (10 years of age and/or younger) will also have 3 categories within this year's contest. - 10. All Measured Zucchini participants, after their official measurement will receive an official Measurement from the Contest officials.

One (1) Grand Prize will be awarded for the adult division: A Trip for Two (2) to the CHIN Italian Winter Picnic 2025 must be accepted as awarded, with no cash substitutions, non-transferable and non-exchangeable, and trips are subject to some restrictions and conditions. No substitutions will be made for the prizes except at the sole discretion of CHIN Radio, which may substitute prize(s) of comparable or greater value.
